EM Normandie Business School (EMN):

EM Normandie Business School (AKA: École de Management de Normandie), established in 1871, is one of the oldest business schools in France and has a campus in Caen, Normandy, France. This campus is located in the northern Higher Education and Research Hub, which hosts some 14,000 students. The campus offers access to sporting facilities and many other services, such as the MediaCenter. The campus also has a spacious and bright cafeteria as well as study rooms that are open until 10 p.m. on week nights.

Student life in Caen blends a rich historical heritage with a dynamic economic and cultural environment. The economy of the Caen la Mer metropolitan region is driven by a number of centers of excellence. Some world-leading companies and institutions are located here, including Citroën, Renault Trucks, Valeo, Robert Bosch Electronics, Carrefour, and more. Caen is renowned for the quality of its student life and the wealth of its cultural life, with art-house cinemas, theaters, concert halls, and nightclubs located all over the city. It also hosts Europe's largest student carnival, which is attended each year by around 35,000 people from all over France and even other countries.

Location:

Caen, Normandy, France

Length of Stay:

One or two semesters

Requirements/Eligibility:

1. Sophomores encouraged to apply; must have at least 60 credits by program start date; seniors may not go in last semester.
2. Must have at least a cumulative GPA of 2.5 or above.

Courses:

EM Normandie is appropriate for both undergraduate and graduate students in SBA.

CAAD: No courses offered for CAAD majors.

CAS: No courses offered for CAS majors.

CEN: No courses offered for CEN majors.

SBA: The school is AACSB-, EQUIS- and EPAS-accredited (i.e. Triple Crown Accredited). Students are offered a variety of courses in business, management, marketing, and more.

NOTE: Students must fill out the AUS course permission form to get their courses approved by the Associate Dean of their school and the Registrar. Upon approval, students will also be informed the grades required to transfer credits. Students must achieve the minimum grade as indicated on the form in order to receive course credit (requirements for credit transfer vary by program). Each study abroad case is subject to approval.

Program Fees and Costs:

Exchange students pay AUS tuition fees for the full course load (12-16 credits) in addition to Student Activities fees. Any additional costs including housing, lab fees, meal plans, books and insurance will be paid directly to the host university.

Financial Grants and Scholarships:

AUS students on grants/scholarships must obtain approval from the Office of Financial Grants and Scholarships before starting a semester abroad at a host university. In cases where the AUS student pays tuition directly to AUS for study abroad, the student will continue to use their AUS grants and AUS-funded

scholarships for that semester abroad. These students should speak with the Financial Grants and Scholarship Manager for more information. Students sponsored by an organization outside of AUS are responsible for making arrangements with their sponsor.

Housing/Accommodation:

EM Normandie has its own online housing platform, where students can find offers from property owners, student residencies, agencies or the school community.

Visa:

Once a student is admitted to EM Normandie, they will receive a Letter of Acceptance and must apply for a VISA D for FRANCE (an extended-stay student visa, with residency permit - VLS-TS). A tourist visa cannot be converted into a student visa in France or in any other country of the European Union. The student has to apply for a student visa from their country of origin. Documents that can be requested by the Embassy for the visa application (non-exhaustive) are passport, proof of acceptance by EM Normandie, proof of financial support, proof of health insurance coverage and/or travel insurance, and proof of vaccinations (some consulates only).

Health Insurance:

The French Health Care coverage is compulsory for students who are in France for more than 3 months and under the age of 28. This coverage starts on September 1; if the program starts in August, students are required to subscribe to a private or travel insurance that covers them until that date. If students do not have a private insurance in their country of origin, EM Normandie will help them subscribe to a French private insurance.
